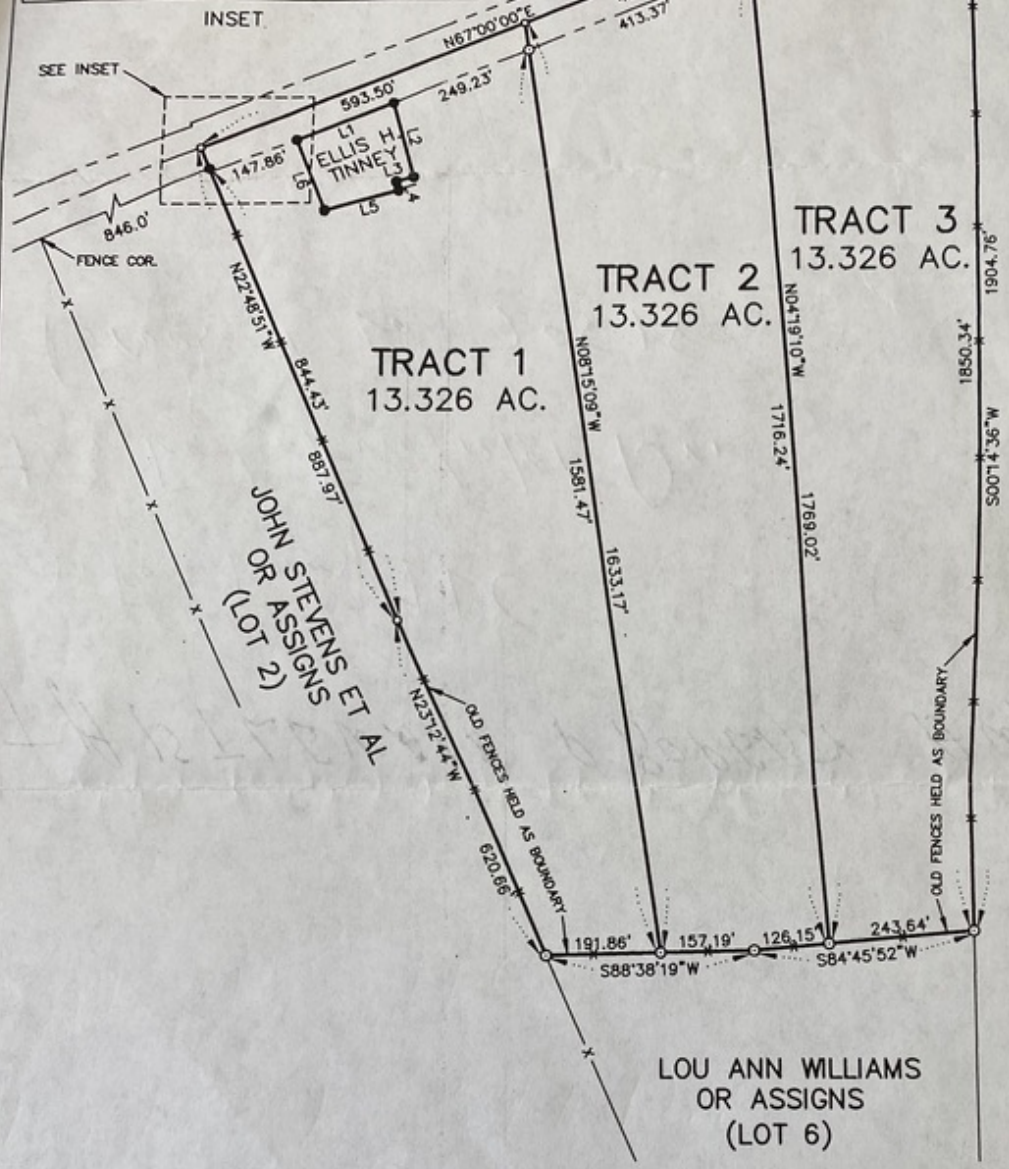


RESET TO JOHN STEPHENS OR ASSIGNS
